5. Make a time commitment of a minimum of three hours to a maximum of ten hours per month.
6. Make a commitment (where able) financially to the ministry.
7. Evaluate on a yearly basis.
8. Put together a prayer list and a supporter list.
9. Sign the YFC Regina | Youth Unlimited Mission Statement and Statement of Faith
10. Be involved in your local church.
11. Make YFC Regina | Youth Unlimited a high ministry priority after your church.
12. Provide a Criminal Record Check prior to Board appointment
