The following Authorization, Release and Indemnity form is a legally binding agreement. Please read it carefully before signing it.

In consideration for Youth for Christ/Portage Inc. and their directors, officers, employees, agents, and volunteers permitting the Participant referred to above (the "Participant") to enter upon the premises of and use Youth for Christ/Portage's facilities and to participate in the programs and activities offered at Youth for Christ/Portage Inc, I agree to the following on my own behalf and on the behalf of the Participant and on the behalf of our heirs, executors, successors, representatives and assigns.

1. I warrant that I am the person legally entitled to make decisions with respect to the care and the affairs of the Participant. I warrant that I am entitled to enter into this agreement on my own behalf, on behalf of the Participant and on behalf of any other parent or guardian of the Participant.
2. I understand that this agreement applies to facilities operated by and programs offered by Youth for Christ/Portage Inc. I understand that this agreement applies whether the participant is an observer, a bystander or an active participant and whether the Participant is at any premises owned or occupied by Youth for Christ/Portage Inc, on an outgoing activity sponsored by Youth for Christ/Portage Inc or travelling to and from such premises or outgoing.
3. I understand that hockey can be dangerous and can result in injury, death or personal property damage to participant and to others.
4. I grant permission to the Participant to attend at the premises of Youth for Christ/Portage Inc, to use Youth for Christ/Portage Inc facilities and equipment and to participate in the programs and activities offered by Youth for Christ/Portage Inc.
5. In granting permission to the Participant to enter upon the premises of and use Youth for Christ/Portage Inc and participate in the programs and activities offered by Youth for Christ/Portage Inc, I accept the condition of the equipment and other facilities and property and I accept that the condition could change to become more hazardous.
6. I understand that the Participant must obey and show respect for the rules and regulations of Youth for Christ/Portage Inc, and I undertake sole responsibility to advise the Participant of the necessity to do so.
7. On behalf of myself, the Participant, and any other parent or guardian of the Participant and our heirs, executors, successors, representatives and assigns, I release Youth for Christ/Portage Inc from any liability, claim, action, suit or demand whatsoever which may arise in connection with or during the Participants attendance at the premises of Youth for Christ/Portage Inc, his/her use of Youth for Christ/Portage Inc facilities

and equipment and his/her participation in the programs and activities offered by Youth for Christ/Portage Inc. Without limiting the generality of the foregoing, this release shall apply to any liability, claim, action, suit, or damage caused by the negligence of Youth for Christ/Portage Inc, the condition of the equipment or the premises or the actions of third parties.

8. I agree on my own behalf, on behalf of any other parent or guardian of the Participant and on behalf of the Participant to indemnify Youth for Christ/Portage Inc and hold it harmless against any liability, claim, action, suit or demand whatsoever which may arise in connection with or during the Participants attendance at the premises of Youth for Christ/Portage Inc, his/her use of Youth for Christ/Portage Inc facilities and equipment and his/her participation in the programs and activities offered by Youth for Christ/Portage Inc. Without limiting the generality of the foregoing, this indemnity shall apply to any liability, claim, action, suit or demand for personal injury, death or property damage, including injuries, death or damage caused by the negligence of Youth for Christ/Portage Inc, the condition of the equipment or the premises or the actions of third parties. This indemnity shall include indemnification for any judgement, and for all costs incurred by Youth for Christ/Portage Inc in connection with litigation.
9. I agree on my own behalf, on behalf of any other parent or guardian of the Participant and on behalf of the Participant that we will not take legal action against Youth for Christ/Portage Inc or against any third party who may claim contribution or indemnity from Youth for Christ/Portage Inc with respect to any liability, claim, action, suit or demand whatsoever which may arise in connection with or during the participants attendance at the premises of Youth for Christ/Portage Inc, his/her use of Youth for Christ/Portage Inc facilities and equipment and his/her participation in the programs and activities offered by Youth for Christ/Portage Inc. without limiting the generality of the foregoing, this agreement not to take legal action shall apply to any claim, action, suit or demand for personal injury, death or property damage caused by the negligence of Youth for Christ/Portage Inc, the condition of the equipment or the premises or the actions of third parties.
10. I acknowledge that Youth for Christ/Portage Inc may, at its discretion, revoke the Participants privileges to attend at the premises of Youth for Christ/Portage Inc, to use the Youth for Christ/Portage Inc facilities and equipment and to participate in the programs and activities offered by Youth for Christ/Portage Inc.
11. In the event that it appears to Youth for Christ/Portage Inc that the participant requires medical or dental attention, testing or treatment (referred to as "Treatment") of any kind while using Youth for Christ/Portage Inc facilities and equipment or participating in the programs and activities offered by Youth for Christ/Portage Inc, I authorize Youth for Christ/Portage Inc to provide or to arrange for the provision of such treatment and to consent to such treatment on behalf of the participant and myself as Youth for Christ/Portage Inc in its discretion considers advisable. I agree to be responsible for any cost of such treatment and I appoint Youth for Christ/Portage Inc as my agent in arranging for such treatment. The release and indemnity provisions above apply to the provision of treatment.
12. I warrant that the information given on this form is correct and complete.
13. I understand that Youth for Christ/Portage Inc uses pictures/video and/or testimonials to capture users' experiences. These may be used for promotional purposes to promote Youth for Christ. I grant Youth for Christ permission to use photo/video/testimonials of my child's or my own experience with Youth for Christ.
